KENTUCKY PERFORMING ARTS

MIDNITE RAMBLE

Kentucky Performing Arts (KPA) has a mission to help people build lifelong relationships with the arts. It achieves this goal through its multiple theatres and venues, as well as a variety of statewide education and outreach programs. KPA works to bring the arts into the community by providing in-person and virtual experiences to children and adults in community centers, healthcare facilities, and schools.

Brown-Forman has been a sponsor of Kentucky Performing Arts since the center first opened in 1983 and a title sponsor of the Midnite Ramble Series for many years. Midnite Ramble is one of our signature series and pays tribute to Louisville’s Walnut Street era that ran from the 1930s to the 1950s.

During that time, Walnut Street was a business and entertainment hub for the city’s Black community and was known for bringing people of all backgrounds together. The series is particularly special because it focuses on diverse artists and art forms. It allows our audience to discover these performers for the first time and has left a lasting impact on thousands of people over the years. It’s

hard to even put into words the importance of our partnership with Brown-Forman, especially coming from the pandemic when everything was closed. The Brown-Forman Foundation supported us through that period of time. That commitment allowed us to jump right back in once performance venues reopened and deliver our programming to new and returning audiences.

SOWING SEEDS WITH FAITH

Sowing Seeds with Faith started in 2017 as an after-school tutoring program for a dozen kids. Since that time, it's grown dramatically and now serves more than 630 students from 17 different zip codes across the Greater Louisville area and Southern Indiana. In addition to academic support, the organization provides year-round mentoring and a summer program.


It isn't a check. It isn't a donation. It's an investment. The Brown-Forman Foundation has helped to evolve our entire program and its

These resources are delivered through programs with schools, mobile units, and outreach to senior citizens.

THE MORTON CENTER

The Morton Center is an outpatient drug and alcohol rehabilitation facility. It started nearly forty years ago and now serves an average of 150 individuals a month. The organization not only provides intensive support and therapy for the individuals in treatment, but also offers sessions for clients' families to better understand and treat the disease of addiction.

THE PARKLANDS OF FLOYDS FORK

The Parklands is a unique parks system in Louisville. It is free, open to the public 365 days a year, home to 60 miles of hard and soft trails, 19.4 miles of the connecting Louisville Loop, and more than 22 miles of Floyds Fork Tributary. In addition to these amenities, the Parklands also offers a robust education program for thousands of students across the community. It averages more than three million visitors a year.

We saw a great need in the community for outdoor science education. The support we receive from the Brown-Forman Foundation allows us to make that possible for kids in our community who wouldn't otherwise get to experience outdoor education.

Our field trip program is designed to serve students who attend Title 1 schools with the goal of exposing them to nature and giving them an enhanced, immersive experience. Teachers tell us, time and time again, about the transformations that come from these moments, which allow their students to move from apprehension to comprehension.

We are so appreciative of all that the Brown-Forman Foundation has done for us. We are now up to providing nearly 10,000 field trips a year. It's great to see this program grow, and it will be really neat to see the impact it continues to make in the years to come.

INVESTING IN EDUCATION

The Brown-Forman Foundation announced a collaboration with five organizations in West Louisville to advance educational opportunities from early childhood through adult learning. Our partnership and corresponding \$50 million financial commitment empower these organizations to increase their reach and create measurable impact by meeting the long-term needs of the next generation of leaders.



Our commitment, which spans ten years, represents the Brown-Forman Foundation’s largest investment since it was created in 2018. The five partner organizations are:

AMPED will receive \$5 million to expand Out of School Time program offerings. Amped will work with community partners aiming to provide support for youth, including social-emotional programming that centers on mentorship and music.



The **LOUISVILLE CENTRAL COMMUNITY CENTER** will receive \$10 million to support its Mini-Versity Child Development Program, which provides health and education equity for families of infants and preschoolers. The funds will create better access to quality early education services, helping children start school with the necessary social, emotional, and academic skills to be successful.



The **LOUISVILLE URBAN LEAGUE** will receive \$5 million to support its education programs, which directly address the achievement gap that adversely affects Black and Brown students through critical programming that focuses on increasing access and removing barriers.



SIMMONS COLLEGE OF KENTUCKY will receive \$10 million to further develop a teacher education program that prepares licensed secondary school teachers and addresses the racial inequities in the local and regional public schools.



The **WEST END SCHOOL** will receive \$10 million to continue to offer boys an academically rigorous school, complete with wraparound counseling, enrichment, extracurricular activities, and invaluable mentorship. The West End School will also receive \$10 million to expand programming to create equitable opportunities for girls.



GRANTS AND HOW TO APPLY

To be considered by the Brown-Forman Foundation and/or the Company for funding, organizations and their programs must meet the following conditions:

- The organization (or fiscal sponsor) must be determined by the IRS to be a tax-exempt organization as described in Section 501(c)(3) of the Internal Revenue Code and a public charity as described in Section 509(a)(1) or 509(a)(2) of the Code, that is operated exclusively for charitable, scientific, or educational purposes.
- Priority is given to organizations located in Louisville, Kentucky.
- The organization's mission and project outcomes must align with one or more of the focus areas of giving.
- Grant submission deadlines are May 1, August 1, November 1, and February 1. Proposals must be received by the submission deadline to be considered for that grant cycle.
- Proposals must provide a sound basis of measurement toward project goals and outcomes.
